Professional Licensure Disclosures by State for the BRCN Respiratory Care Program

As a graduate of BRCN, you will seek application for initial licensure as a respiratory therapist. This process varies for each state. Contact information (Internet link) is provided for each state in the table below.

Steps for Initial Licensure Application

Graduates applying for their first respiratory therapist license must complete the following steps:

- Pass the exam to earn the credential required for licensure by state law.
- Search the state licensing board website to find the application for licensure as a respiratory therapist in that state and follow the directions for completing the application.

States require fees for licensure and these fees vary by state.

Eligibility for Licensure

The Certified Respiratory Therapist (CRT) is the minimum required credential for licensure in some states whereas the Registered Respiratory Therapist (RRT) is the minimum required credential for licensure in other states.

The exam that must be passed to earn the credential for licensure is administered by the National Board for Respiratory Care (NBRC). Students are encouraged to visit the NBRC website (https://www.nbrc.org/) to learn more about the examination and earning credentials.

Earning the CRT

Graduates must pass the Therapist Multiple-Choice (TMC) exam to earn the CRT credential. Graduates of BRCN's respiratory care program are eligible to take the TMC because they are graduates of a respiratory care program accredited by the Commission on Accreditation for Respiratory Care (CoARC). CoARC is the successor organization to the Joint Review Committee for Respiratory Care of the Council on Allied Health Education and Accreditation.

Earning the RRT

Graduates must pass the Clinical Simulation Examination (CSE) to earn the RRT credential. Eligibility to take the CSE are:

- Pass the CRT with the high-cut score. OR
- Practice as a CRT for at least two years before applying for and then passing the CSE.

Other Licensure Requirements

All states require applicants to have a high school diploma or the equivalent of a high school diploma. BRCN graduates meet this requirement because students are required to have a high school diploma or GED for acceptance into the respiratory care program.

Some states may require a background check to determine the applicant for licensure is of good moral character.

Required Credential for State Licensure as a Respiratory Therapist

The table below identifies each state's requirements for the initial license as a respiratory therapist. The table also discloses how BRCN'S respiratory care program meets those requirements and our graduates are eligible for initial licensure in that state.

Please note that the requirements found in the table are subject to change. BRCN recommends that you contact the appropriate state licensing agency to obtain the most up-to-date information.
